The entrant and driver understand that this entry, if accepted, constitutes an agreement with the organizers to take part in the event unless prevented from doing so by circumstances beyond the control of the driver and/or entrant. The entrant certifies that he has studied the Racing Regulations of the appropriate Sanctioning Bodies Sanctioning this Series, the Series Regulations and the Event Supplementary Regulations for the Series and agrees to abide by these rules and regulations. The entrant, in signing this agreement and in consideration of the right to use the race course under the conditions outlined in the applicable regulations, agrees to use the race course at his own risk. The entrant further agrees that he, the drivers, and all crew members shall execute a release agreement prior to their admission to the race course. The entrant, and the drivers he has nominated, agree to permit the promoter/ organizer of the event, and their assigns the use of their name, voice, and/or likeness for news, publicity and feature use including radio, television, motion picture film, newspapers, magazines, internet or other electronic or online media, and all other media in connection with advertising and for purposes of trade. If an entrant or driver is under the legal age of majority, this form must be countersigned by the appropriate parent or guardian. The entrant has read and familiarized himself with the Racing Regulations of the appropriate Sanctioning Bodies Sanctioning this Series, the Series Regulations and the Event Supplementary Regulations for the Series and agrees to be bound by them. The entrant in signing this entry form and agreement and in consideration of the right to enter and compete in the event agrees to participate in the event and accept all risks. **Crew Members:**

- Each entry allows a team to purchase Crew Credentials for \$10/\$20 each (member/non-member).
- Additional Crew Credentials may be purchased for: \$20/\$30 each (member/non-member).
- Each Crew Members must register for each event, and must posses a valid Event Credential.
- To register each Crew Member must submit a Crew Credentials Application.
- Credentials may be picked up at the registration window.

**Drivers:**

- Each entry allows for two drivers.
- Additional Drivers must pay the appropriate entry fees as outlined in the NASA Endurance Series Rules.
- There is no limit to the number of drivers per team.
- Credentials may be picked up at the registration window.

**Entry Fees:**

NOTE: "Divisions" are INDEPENDENT of Entered Class. Any driver may enter either division or both divisions. The prize fund could be substantially higher in the Pro Division. (See Endurance Series Rules online at [www.nasaproracing.com](http://www.nasaproracing.com)).

The Sportsman Division: (Prize fund qualifications listed in the rules)

Entry fee is \$450 per team, which provides entry for one car and up to two drivers. All additional drivers must pay a \$100 entry fee each. (i.e. Two drivers sharing a car would pay \$450.) The team captain is responsible for paying all of the fees and submitting all of the proper paperwork.

The Pro Division: (Substantial prize fund, see rules)

The Pro Division is only offered for the 12-hour endurance race. The entry fee is \$1475 per team, which provides entry for one car and up to two drivers. All additional drivers must pay a \$150 entry fee each (i.e. two drivers sharing a car would pay \$1475). Extra amenities and hospitalities may be afforded to each Pro Division team that registers with the NASA National office at least two weeks in advance. All Pro Divisional teams must indicate their division on their entry forms or they may be counted as a Sportsman Team. The team captain (owner) is responsible for paying all of the fees and submitting all of the proper paperwork.
